

COVID-19 Vaccination Certificate (Vaccine Passport)

You may request a vaccination certificate (vaccine passport) that shows records of COVID-19 vaccinations received during the Special Temporary Vaccination Period that ended March 31, 2024,.

If you would like a vaccine passport, please apply online or by mail as instructed below.

- ※ If you have any questions regarding vaccination certificates for COVID-19 routine vaccinations received after October 15, 2024, please contact a health center near you. (Health centers cannot issue vaccine passports for optional COVID-19 vaccinations received on or after April 1, 2024.)
- ※ City of Nagoya vaccine passports can only be issued to persons who were residents of Nagoya City at the time of their vaccination (and received their vaccination using vaccination vouchers provided by the City of Nagoya).
- ※ There are passports for overseas and domestic use. Vaccine passports for overseas use can also be used as passports for use domestically (Japan).
- ※ In Japan, a Certificate of Vaccination for COVID-19 and a Record of Vaccination for COVID-19 are still valid forms of verifying your vaccination(s).

How to Apply Online

- ① To go to the City of Nagoya official website, scan the code on the right or search for City of Nagoya COVID-19 Vaccination Certificate online. From there, go to the COVID-19 Vaccination Certificate Application page on the City of Nagoya Online Application Service.

- ② Prepare a photo of the following documents (document verifying your identity), and after reading and agreeing to the Terms and Conditions, submit the application.
 - ☐ A photo of a document verifying your identity
(Your current address (as written on your Resident Record) must be written on the document.)
(For domestic use, vaccine passports, send documents with your name and date of birth listed.)
 - ☐ A photo of your passport (for overseas use vaccine passport only)
【Required documents in special cases】
 - If the name on your passport is different from your legal name (your maiden name or an alternative surname or first name), a photo of a document we can use to verify the name on your passport is also required.
(Your My Number Card, driver's license, Family Register (Certificate of All Records or Certificate of Individual Records), Resident Record, or other document that has both your legal name and the name on your passport.)
 - If you have a representative applying on your behalf: a copy of a Power of Attorney signed by you (the grantor) or a document which verifies the qualifications of your legal representative in PDF or other format, as well as a photo of a document which verifies the personal information of the agent.
- ③ A link to download your vaccination passport will be sent to the email address you provided on your application approximately one week after submitting an application.

※It may take some time to process, so please apply ahead of time.

※If any documents are incomplete, or if there are any concerns regarding your vaccination records, we may contact you via phone or other methods.

How to Apply by Mail

① Mail the required documents

- ☐ COVID-19 Vaccination Certificate (Vaccine Passport)
Application Form (The application form is available to download on the City of Nagoya Official Website)
 - ☐ Copy of Passport (for overseas use vaccine passport only)
 - ☐ Self-addressed Envelope (*stamp attached)
(Write a return address.) (For express delivery, put enough stamps to cover the cost and write 速達 “expedite” on the envelope with a red pen.)
 - ☐ Copy of a document verifying your identity
(The document must have a return address written on it.)
(For domestic use, vaccine passports, send documents with your name and date of birth listed.)
 - ☐ A copy of your Certificate of Vaccination, or Record of Vaccination (If you are in possession of one)
- 【Required documents in special cases】**
- If the name on your passport is different (for example maiden name, different name, alphabetized), send a copy of document we can use to verify your name. (Copy of My Number Card, driver’s license, Family Register (Certificate of All Records or Certificate of Individual Records), Resident Record, or other document that has both your legal name and the name on your passport.)
 - A Power of Attorney signed by you (the grantor) who has an agent applying on your behalf or a document which verifies the qualifications of the agent applying on your behalf, as well as a copy of a document which verifies the personal information of the agent.
