

URGENT NOTICE

Evacuation Notice

Director, Higashi Ward
Chief, Higashi Police Station
Fire Commissioner, Higashi Fire Station

An unexploded 250 kg / 550lb bomb was found at Aoi 1-chome, Higashi Ward at around 4:00 p.m. on October 24. The Japan Ground Self-Defense Force will remove the bomb at the date and time below.

Due to the risk of an explosion during removal, there will be an evacuation zone set as shown on the reverse side of the sheet based on Article 63 of the Basic Law on Natural Disasters. The zone will be completely sealed off for your safety.

All residents of the designated evacuation area must evacuate outside the area by the time designated below. We thank you for your cooperation and understanding.

The locations listed below are open to the public for use as evacuation shelters but you do not have to go to the evacuation shelter listed as long as you stay outside of the evacuation zone.

Date of Removal	Sunday, December 15, starting at 10:00 a.m.
Evacuate by	9:30 a.m.
Evacuation shelters	- Aichi University, Kurumamichi Campus 1F (10-31 Tsutsui 2-chome) - Aoi Community Center (2-9 Aoi 3-chome) - Higashi Sakura Kaikan Gallery (6-30 Higashi Sakura 2-chome)

* You do not have to go to the evacuation shelter listed, as long as you stay outside of the evacuation zone.

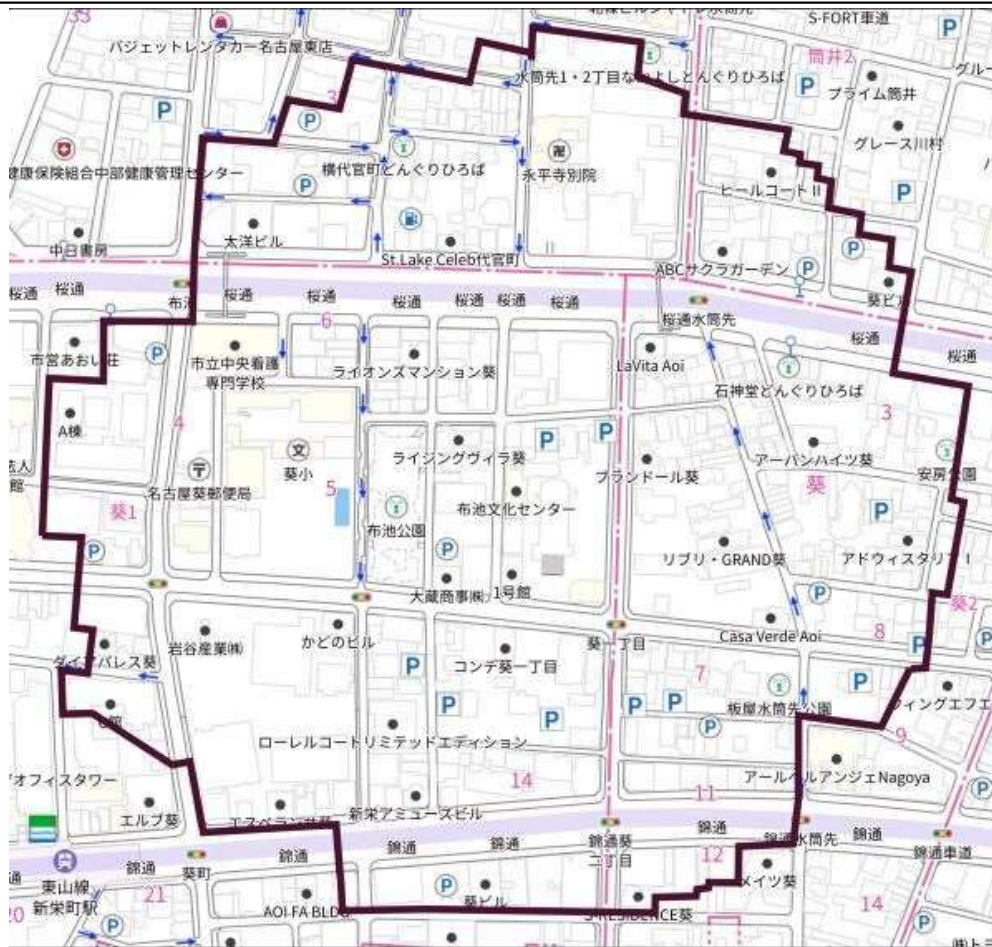
IMPORTANT NOTE

1. Make sure to turn off any fire sources and lock your door before evacuating.
2. If you will evacuate by car, leave with time to spare in case of traffic jams.
3. There are no parking facilities at the evacuation shelters; please do not come by car. Also, please be aware that food and drink are not provided at evacuation shelters; please bring your own if you need.
4. We ask for your cooperation in helping senior citizens or those with disabilities living in your neighborhood to evacuate safely.
5. As soon as the bomb removal is completed, we will announce the lifting of the evacuation order on the City of Nagoya Official Website, through wireless broadcast system, public announcement vehicles, and other methods.
* While the previous removal works done in 2022 and 2023 in Nagoya finished by 1:00 p.m., every situation is different, and the time the work takes may vary. When the work will end has not been determined.
6. The removal work will be held even in bad weather. If the removal work cannot be held on November 30 for any reason such as natural disasters, it will be postponed to Sunday, December 22.
