

## About the enrollment grant program

This program aims to offer 70,000 yen per third-year junior high school student to reduce financial burdens when enrolling in high school, etc. and support advancement to the next stage of education. (This is a non-repayable grant program.)

**Eligibility to the program** Applicants must meet all the requirements ① to ④ below.

- ① The student and the guardian(s) reside in the City of Nagoya as of July 1, 2025.
  - ② The student is enrolled in junior high school, etc. (including upper courses of compulsory education schools, lower courses of secondary education schools, or junior high school courses in special needs education schools) in Aichi Prefecture as of July 1, 2025.
  - ③ The student will enroll in a high school, etc. covered by the program in Aichi Prefecture. (Correspondence courses outside the prefecture are also covered.)
  - ④ The student is deemed by the board of education to require support for school attendance due to financial reasons.
- \* Those who receive public assistance expenses or placement expenses under the Child Welfare Act are ineligible for the enrollment grant because expenses incurred when enrolling in high school are disbursed under the relevant program.

## Those who are deemed by the board of education to require support for school attendance due to financial reasons

Those who fulfill either of the requirements below are eligible.

- The total amount of “tax base amount of the municipal inhabitants’ tax in FY2025 × 6% – adjusted deduction amount of the municipal inhabitants’ tax × 3/4” of all the guardians is less than 174,300 yen.\*
- Those who are determined to be eligible for the city’s school financial aid from September onward (\* except for persons requiring public assistance prescribed in the Public Assistance Act)

\* Unlike the school financial aid, the amount used to determine eligibility is calculated based on the guardian(s)’ revenue instead of the household revenue.

\* Even if the amount exceeds the baseline amount of 174,300 yen, when the revenue decreases significantly based on grounds not attributable to the guardians (e.g., unemployment) and the expected revenue for 2025 qualifies for exemption from the per income levy on municipal inhabitants’ tax, eligibility for a sudden change in household income may be recognized. For details, refer to the city’s webpage.

\* If the tax jurisdiction is not a designated city, the calculation formula is “tax base amount of the municipal inhabitants’ tax × 6% – adjusted deduction amount.”

\* Eligibility cannot be determined if you are tax-exempt due to residence outside Japan or if you do not declare inhabitants’ tax.

\* The amount used to determine eligibility can be estimated by yourself based on the following:

“Reiwa-7-nendo shimin-zei, kenmin-zei, shinrin-kankyo-zei nozei-tsuchi-sho ken zeigaku kettei tsuchi-sho” (FY2025 notification of municipal inhabitants’ tax, prefectural inhabitants’ tax, and forest environment tax and written notice of determination of the tax amount)

This is “shi-kenmin-zei no oshirase” (notice of municipal and prefectural inhabitants’ tax), which is delivered from late May to early June.

\* The amount includes deductions, including furusato nozei (hometown tax). For the accurate adjusted deduction amount, check your taxation certificate or Mynaportal account.

Calculation formula:

(tax base amount of the municipal inhabitants’ tax  × 0.06) – (adjusted deduction amount  × 0.75)

You are eligible if the total amount calculated for all the guardians is less than 174,300 yen.

### Schools (national, public, and private) covered by the program

- High schools, upper courses of secondary education schools, colleges of technology, and upper secondary courses in specialized training colleges in Aichi Prefecture
  - High school correspondence courses across Japan
  - Specialized training colleges and miscellaneous category schools in Aichi Prefecture (limited to schools covered by the school attendance support program for high schools)
    - Schools designated to offer courses to train professionals with national qualifications among specialized training colleges (general courses) and miscellaneous category schools
    - Schools for international students designated by the Minister of Education, Culture, Sports, Science and Technology to be covered by the school attendance support program for high schools, etc.
- \* Students who will enroll in graduate courses in high schools and high school courses in special needs education schools are ineligible.
- \* Students who will enroll as non-credit subject students and auditors are ineligible.

Application deadline Tuesday, September 30, 2025

### Application method

- ① Access the city's webpage from the 2D code on the right or the URL below.
- ② Click/tap “名古屋市電子申請サービス” (City of Nagoya online application service) on the displayed webpage.
- ③ Enter necessary information and submit the form via the online application service.

\* If it is difficult to apply online, contact the Educational Affairs Division of the Board of Education. We will provide information regarding the application method.

### Documents (image files) to be submitted when applying online

Image files of the following documents must be submitted. You are advised to prepare them before applying.

①	All applicants	Student ID booklet or certificate of enrollment of the junior high school, etc. where the student is currently enrolled	A page which indicates the student's name/name of the school where the student is currently enrolled
②		Passbook account (in the student's name only)	An account in the guardian's name is not accepted. (If the student does not have an account, it is necessary to create one.)

\* If any guardian was registered as a resident outside Nagoya City as of January 1, 2025, it is necessary to submit the FY2025 taxation certificate (*shi-kenmin-zei shomei-sho* [municipal/prefectural inhabitants' tax certificate], etc.; the name varies depending on the municipality), which was issued by a municipality in which the guardian resided, for all the guardians.

\* When applying for a sudden change in household income, other documents are required. For details, refer to the city's webpage.

\* Additional documents may be required to check other requirements.

Eligibility determination In around December 2025, a notification of the decision and a guide to claim the grant will be sent to the email address which you entered to apply.

Grant claim By the end of March 2026, attach an image file of the student's entrance exam result (e.g., an admission notice from high school, etc., a screenshot of the admission list published online, an admission certificate) and claim the grant through the city's webpage or the webpage for claiming the grant on the City of Nagoya online application service, which will be provided when the decision is notified. The grant will be remitted to the student's bank account about two weeks after claiming the grant.

### Notes, etc.

- Those who are determined to be eligible for the city's school financial aid also need to apply.
- The grant may be received in addition to other scholarships.
- If there are siblings enrolled in the same school year, it is necessary to apply for each of them.
- The application information will be shared with the school in which the student is currently enrolled as necessary to check the application requirements, such as the enrollment status.
- It is possible to apply even if the student has not decided to enter a high school, etc. covered by the program at present.
