

For International Residents

- ◆Make sure pay your municipal tax by the due date. Additional delinquency charges will be added if taxes are not paid in full by the due date. Failing to do so after receiving a reminder (‘督促状’) may result in a tax lien being placed on your property.

Where to pay your taxes

You may pay your taxes with a payment slip at banks, post offices, convenience stores, Municipal Tax Offices, ward/branch Offices and the City Hall.

How to use a Tax Bill

When paying for all 4 installments at once, bring all (4) payment slips. Otherwise, bring the payment slips for the installment you wish to pay to the place of payment.

Full amount due (All 4 installments)

1 installment
