

To Foreign Nationals

- ◆ You have overdue residents' tax. If you do not fully pay your residents' tax by the deadline stated on the overdue notice (督促状), a tax lien may be placed on your property.
- ◆ You will be charged delinquency fees due to failing to pay by the previous deadline. If you are charged delinquency fees, a payment slip will be sent to you at a later date. Please pay for the fees in full.
- ◆ If you are having difficulties paying for your residents' tax, ask someone who can speak Japanese to help you in contacting one of the following offices below.

Where to Pay Your Taxes

Please pay your taxes with a payment slip at: a bank, post office, convenience store, tax office, main or branch ward office, or at the city hall.

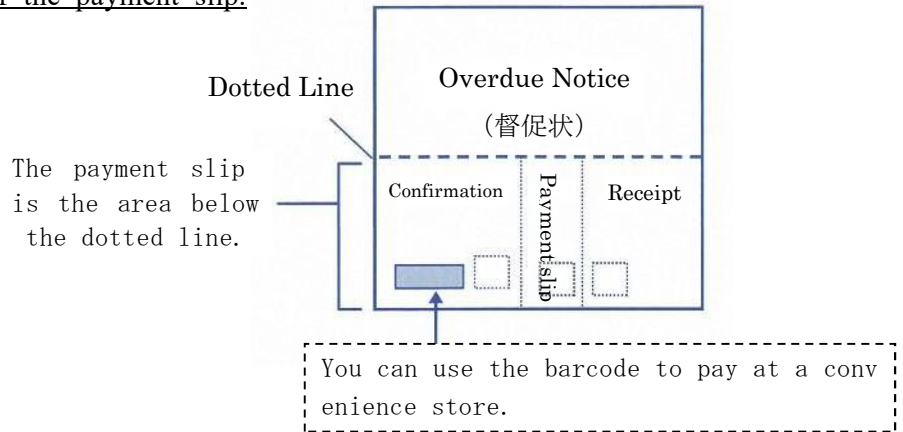

《How to use payment slips》

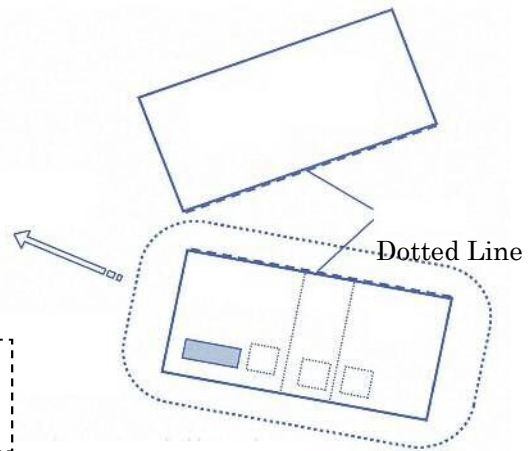
① Please check the contents of the payment slip.



② Separate the tax payment notice (upper half) from the payment slip (lower half) along the dotted line, and bring the payment slip when making a payment.

Please bring your payment slip to a location that handles tax payments..

* The payment slip will be processed by machine, so be careful not to stain or bend it.



③ Please keep your receipt in a safe place after making a payment.
